Notes.

- (1) To apply for the Japan Industries Association of Radiological Systems (JIRA) member price (*) stated in the exhibition fee, you must be a member of JIRA six months prior to the exhibition and at the time of the exhibition.
For membership registration, please apply to the Japan Industries Association of Radiological Systems listed in the 'Contact for enquiries about the exhibition' section.
- (2) No changes to booth categories, increase or decrease in area, etc., are permitted after notification of the booth decision.
- (3) It is forbidden to transfer or sublet all or part of the allocated booths to third parties.
- (4) Please refer to the section 'Cancellation after application' for information on cancelling an exhibition.
- (5) This is an exhibition attached to an academic conference aimed at professionals in the fields of medicine, dentistry and pharmacy, with the aim of improving and developing science.
Based on this purpose, exhibitors who fall into any of the following categories may be refused.
 - Exhibits that do not target medical professionals
 - Exhibits by companies that mainly deal in used medical equipment (whether purchased or sold)
 - Other exhibits that the organisers consider unsuitable for the purpose and objectives of the exhibitionPlease note that the final decision on whether or not to exhibit will be made by the organisers after a preliminary screening. Please note that the organiser will make the final decision on whether or not to allow an exhibitor to exhibit.
- (6) All foundation booths with foundation decoration will use system panels, with a height of 2.7m for both A and B booths. For details, please refer to the attached shape drawing.
- (7) Please refer to the exhibition guidelines to be issued at a later date regarding height restrictions for space booths.
- (8) In addition to the exhibition fee, electrical installation and electricity usage fees will be charged.

Exhibit areas for related medical societies and medical research facilities

- (1) Exhibit areas are limited to related medical societies, medical research facilities and medical NPOs in accordance with the aims of the Japan Radiology Society (JRC), for a fee.
- (2) The standard size is W2m x D1.5m, with power sockets, signboards, desks and chairs as specified.
- (3) The exhibition fee is JPY102,630 (including consumption tax) for booth C.
- (4) The exhibition will be set up in a dedicated corner (please contact us for details).
- (5) Exhibitors who do not meet the objectives of the event may be refused. Please understand.

Joint exhibiting

- (1) Joint exhibiting by several exhibitors is permitted at the exhibition.
- (2) Exhibitors who are members, non-members or a combination of members and non-members of the Japan Industries Association of Radiological Systems may jointly exhibit with other exhibitors.
Up to five companies, including the organising company, may jointly exhibit with a combination of members and non-members of the Japan Industries Association of Radiological Systems.
Please indicate the organising company and the allocation of the exhibition fee in the appropriate boxes on the web application form.
If a member and a non-member jointly exhibit, the exhibition fee and the order in which booths are drawn will be determined by the non-member.
- (3) Once notification has been given of the number of booths allocated, changes such as an increase or decrease in the number of co-exhibitors are not permitted.
- (4) Note. (3) applies also to joint exhibitors. Please apply after careful consideration.

How to apply to exhibit

- (1) Only web-based applications are accepted. The procedure is as follows.
- (2) Click on the 'ITEM2026 Exhibit Application Button' on the JRC website.
- (3) Fill in or modify the required information on the application page and click the application button.
Please note that an acceptance email will be sent to your registered email address.

Exhibition briefing and booth allocation lot drawing

- (1) The exhibition briefing and booth allocation lot drawing are scheduled for 5 November 2025. Exhibitor applicants will be informed separately.
- (2) Notification of the lottery and the decision on the number of booths (size of exhibition booths) for each company that has applied, the venue plan and booth allocation will be sent by email by 3 October 2025 (Friday).
- (3) Please download and print the documents from the website provided in the email.

Exhibition fees Request

An invoice will be sent together with the notification of the finalisation of booths (size and location). (scheduled for late November).

Please transfer the determined exhibition fee to the bank account indicated on the invoice by the deadline below. Failure to make payment by the deadline may result in the cancellation of the exhibition.

Deadline for payment of exhibition fee (to be strictly observed) **Friday, 30 January 2026**

Cancellation after applying to exhibit

If you cancel your application to exhibit for personal reasons after midnight on the day following the application deadline, the following cancellation fees will be payable.

- 1) From 12 September to 31 October 2025: 20% of the determined exhibition fee
- 2) From 1 November to 4 November 2025: 50% of the determined exhibition fee
- 3) From 5 November 2025 onwards: Full amount of the determined exhibition fee

Measures to be taken if exhibitions are cancelled due to natural disasters, etc.

If the organiser (Japan Radiology Congress) considers it difficult to hold the exhibition due to the occurrence of a natural disaster or a large-scale epidemic of an infectious disease, the exhibition fee will be refunded after deducting the necessary expenses, taking into account the situation at the time of cancellation.

- (2) Applications to exhibit through agents or contractors of exhibiting companies will not be accepted.
- (3) Payment of the following expenses related to the exhibition cannot be made through agents or contractors of the exhibiting company.
 - Electricity and overtime charges for the use of the exhibition hall.
 - Automatic fire alarm installation fees
 - Anchor bolt usage fees (including repair costs)
 - Additional display boards and exhibitor cards for unapproved medicinal products
 - Additional work cards, etc.

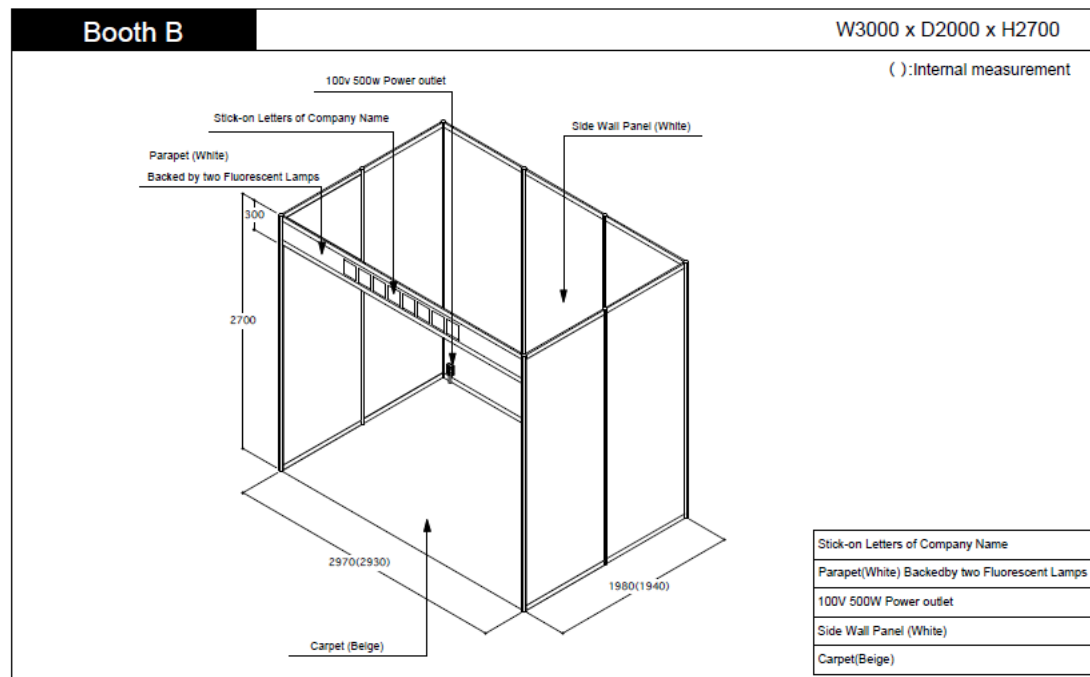
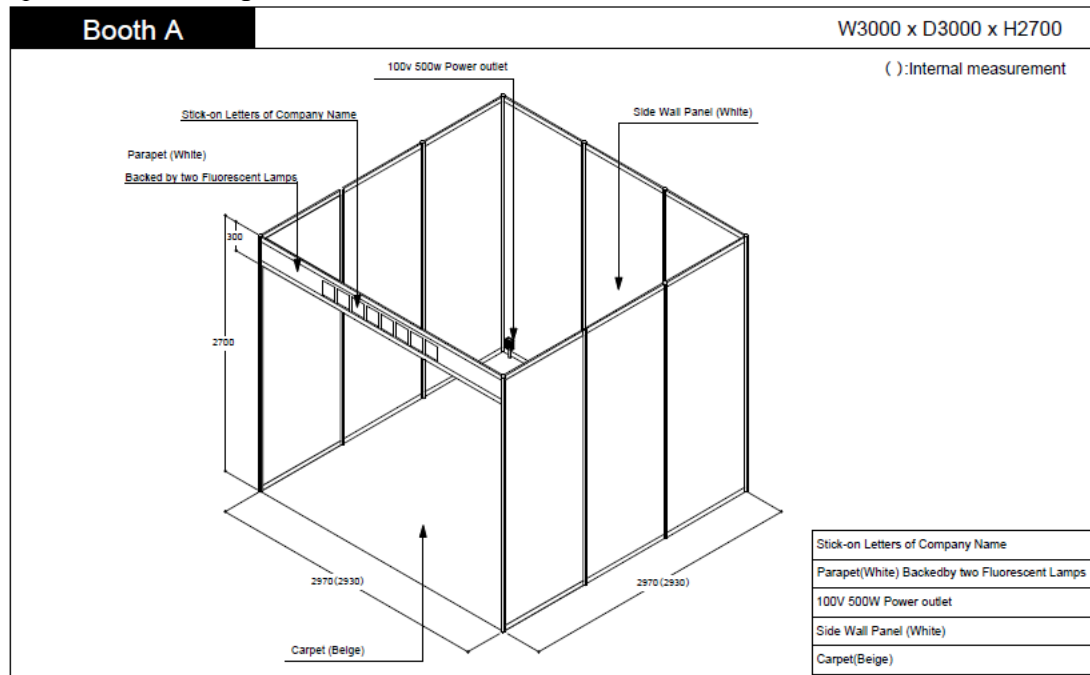
